# **Election Canada Compliance Information**

As you know, since 2015 Elections Canada has adopted new regulations for campaigns and service providers to remain in full compliance.

PrimeContact now requires a notarized copy of your Official Agent's ID or Candidate's ID to register calling on behalf of your campaign with Elections Canada. You will also be required to provide this notarized ID as a digital upload when you register with the CRTC.

# **Notarization of ID to Order Election Services**

Notarization is the authentication of a document by a notary; it certifies that the copy of identification in question is a true copy of the original. Canadian notaries may vary slightly from province to province in their roles or powers, but are usually regulated by a governing body, typically under provincial jurisdiction. In Quebec, Commissioners of Oaths (Commissaires à l'assermentation) serve to authenticate legal documents.

All copies of identification must be accompanied by an attestation by a notary, or a Commissaire à l'assermentation in Quebec (the Attestor). The Attestor should photocopy the document that will be used as identification for the purpose of the Voter Contact Registry, ensure that it is legible, valid (i.e. not expired), and shows the name of the person whose identification is being copied, the identification number, the name of the issuing authority, the date of issue, and a photograph of the person.



## **Sample for the Notary**

The Attestor will provide an attestation on the photocopy and date and sign the attestation. The Attestor must provide a statement that he/she certifies that the document is a true copy of the original piece of identification produced. The following is an example of an acceptable statement:

# **Examples of identification**

The following is a non-exhaustive list of the types of identification that will be accepted:

- Driver's License
- Provincial/Territorial Identification
- Canadian Passport
- Provincial Health Card
- Secure Certificate of Indian Status (SCIS)
- Permanent Resident Card (provided by Citizenship and Immigration Canada)
- Citizenship Certificate prior to 1 February 2012 (provided by Citizenship and Immigration Canada)
- Foreign Passport
   U.S. Passport
- NEXUS Card
- Canadian Forces Identity Card

You will need the following information in order to complete your registration:

#### What You Will Need:

- **Item 1)** A digital copy of your Notarized ID. (PDF files and image files are accepted.)
- Item 2) The name of your candidate.
- **Item 3)** The name and address of your Official Agent / Official Representative.
- Item 4) The name of the Service Provider -- PrimeContact Inc.

### **Registration Step-by-Step:**

- Step 1: Visit <a href="https://crtc.gc.ca/eng/phone/rce-vcr/reg3.htm">https://crtc.gc.ca/eng/phone/rce-vcr/reg3.htm</a> and click start registration.
- **Step 2**: Login using your GC-Key (You can create a GC-Key on that page in about a minute if you don't have one. Just click on "Register for GC-Key")
- **Step 3**: Fill out the online registration form using the details listed below.
